INSURANCE

Due to the strenuous nature of our trips and the remoteness of our destinations, we will provide a travel insurance policy application to all trip members upon receipt of an application. While Sherpa Shangri-La Treks & Expeditions will attempt to secure the services of a trip doctor, we cannot guarantee the same, nor can a doctor be expected to be able to treat every form of emergency. We strongly urge each member to take out travel insurance to cover themselves for trip cancellation and medical evacuation

TERMS AND CONDITION FOR RESERVATION

Reservation:

01. For treks that require domestic flights, bookings (30% deposit for total cost) should be made 3 months ahead. Booking for normal trek will be confirmed upon receipt 25% deposit of total cost before two months. Full payment will be due prior or 30 day before to departure.

02. For other treks reservation can be accepted as let as 3 weeks (if correspondent made by letter, in case for fax or telephone, at least 2 weeks is necessary and 75% deposit of total cost can be accepted for booking) before the departure but earlier booking are advised. The balance and the full payment must be settled before 3 days departure of the group from Kathmandu.

CANCELLATION:

01. For any cancellation made 45 days before the departure date there shall be no cancellation charge.
02. 50% service charge against total cost of trip shall be leaved if cancellation is made prior to 7 days before departure date and no refund from 25 or 30% deposit shall be granted for any cancellation made with in these days. Government holidays are not counted.
03. No refund for no-shows, incomplete treks and delay arrivals of the clients whatsoever reasons.

TOUR LEADER:

For group of +15 full paying persons, tour leader will be free of trekking cost only.

CHILDREN:

Children up to 12 years are charged 50% of normal rate.

TRIP BOOKING:

Deposit accepted by cash, traveler cheques or bank transfer in following bank A/c

GENERAL CONDITIONS FOR TREKKING

Sherpa Shangri-La Treks & Expeditions P. Ltd., accepts no responsibility for the following;

01. Payment of meals of hotel bills in Kathmandu should a charter or scheduled flight or other from of transportation fail to leave Kathmandu or not reach its destinations for reasons beyond the control of Sherpa Shangri-La treks.

02. Payment of flights or other transportation not arranged by Sherpa Shangri-La Treks and for lodging or meals should any one wish to return from a trek early or for any other reasons.

03. Payment of helicopter or other aircraft evacuation, hospitalization, medical treatment or drugs in the event of the accident or medical emergency.

04. Occurrences covered under the 'Assumption of Risk & Release' from whether or not this agreement has been seen or signed.

05. Sherpa Shangri-La Treks reserve the flight to change or alter any trek or itinerary at anytime for reasons beyond the control of Sherpa Shangri-La Treks. These could include but are not limited to snowfall, cancellation of flight or Govt. closure as far in advance as possible.

NOTE: As many of the contingencies may affect trekkers separated from their groups, leaders are requested to inform all group members of this condition.

Any refund payable will usually be made in Nepalese currency due to foreign exchange control applicable in Nepal.

Policy

Release and Assumption of Risk

By undertaking this trip, you acknowledge that there are risks involved with any adventure, sport or activities in the outdoors. You acknowledge these inherent risks, which include, among others, the risks of injury or illness in remote places without medical facilities; the ever-present danger posed by the forces of nature; remote areas' domestic flights, bad weather, during the trek/climbing, other means of transportation. Knowing these risks, you fully assume all risks of illness, injury or death, and release "**Sherpa Shangri-La Treks & Expeditions**" (**Nepal**) their agents, associates & suppliers from all actions, claims or demands for damages or expenses resulting from your participation in the trip. You acknowledge that the obligation stated herein is binding upon yourself, your heirs, executors & administrators, member of your family & any minors you choose to bring with you.

You also agree that any medical expenses incurred, including helicopter aircraft, will be your sole responsibility and that you will pay all such expenses.

If you obtain trip information from us for a group consisting of yourself and one or more additional persons, you agree to act as our agent in seeing that each member of such group obtains a copy of all documentation that you obtain from us in connection with such trip.
